- On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
  - The institution has acquired the land for setting up the teacher education institution.
  - b. The institution has made arrangements for conducting the course in the rented premises.
  - The institution has created an Endowment Fund of Rs.5 lakhs and a Reserve Fund of Rs. 3 Lakhs.
  - The institution has selected the Principal and Seven lecturers for the d. said course and the list of faculty members has been approved by the affiliating University.
- Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the 3. NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Deccan B.Ed College, Noorani Moholla, Near Peer Bangali Darga, Ring Road, Gulbarga-585104, Karnataka for Secondary(B.Ed) course of one year duration from the academic session 2004-2005 with an annual intake of 100 students subject to fulfillment of the following.
  - The institution will ensure that Principal and Seven faculty members duly approved by affiliating University are in position for an intake of 100 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case not later than one month from the date of commencement of the

- b. The institution shall, within one month of the receipt of recognition order, convert the Endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
- The institution shall shift to its own premises / building within three years from the date of recognition. (in case the course is started in rented premises)
- The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the affiliating University, UGC, State Government etc.
- The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.

#### ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12 2014.

- AND WHEREAS, the institution, Deccan B.Ed College, Noorani Mohotia, Near Peer Bangali Darga; Ring Road, Gulbarga-585104, Karnataka has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed which require additional facilities.
- AND WHEREAS, on scrutiny it is found that the institution has not shifted to its own premises as stipulated in its Formal Recognition order dated 09.12.2004.
- AND WHEREAS, the SRC has decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,
  - The institution shall submit all documents including land, building, Encumbrance Certificate, Land Use Certificate, Building Plan, approved staff list, pertaining to shifting to own premises to the SRC before 31<sup>st</sup> July, 2015 falling which recognition will be withdrawn.
  - The Regional Committees shall inspect the proposed premises during August-September-October, 2015 and if on inspection it is found that the institution dose not fulfill required norms of infrastructure recognition will be withdrawn.
  - Further, with regard to the second unit the institution shall create additional facilities that indude (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
  - The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff Cist in the specified proforms available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
  - The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- is. NOW THEREFORE, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to Deccan B.Ed College, Noorani Moholla, Near Peer Bangali Darga, Ring Road, Gulbarga-585104, Karnataka for conducting B.Ed programme of two years duration with an annual intake of 100 students each for two basic units from the academic session 2015-16 subject to fulfilment of the conditions mentioned at 4.(II) and 4.(III) herein before 31 July. 2015 and those mentioned at 4.(III), 4.(IV) before 31.10.2015.

#### CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely Deccan B.Ed. College, Noorani Mohalla, Near Peer Bengali Darga, Ring Road, Gulbarga, Karnataka-585104 Vide SRC (NCTE) order No. F.SRO/NCTE/B.Ed./2004-2005/9213 dt. 09.12.2004 for Secondary B.Ed. course of one-year duration with an annual Intake of 100 students from the academic session 2004-2005.

- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution consented to come under new Regulations vide a notarized affidavit dated 16.01.2015. A revised provisional recognition order (RPRO) was issued to the institution on 18.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-2016.
- AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice was issued to the institution on 05.02.2019. The institution has not submitted reply of Show Cause Notice.
- AND WHEREAS, the matter was further considered by the SRC in its 381th meeting held on 31st Oct & 01st November, 2019 and the Committee decided to issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 06.12.2019. The institution has submitted reply vide letter dated 19.12.2019.
- AND WHEREAS, the SRC in its 393th Meeting held on 05th & 06th January, 2021 considered the matter and decided to withdraw the recognition for conducting B.Ed. Programme. Accordingly, as per decision of SRC a withdrawal order was issued to the institution on 22.01.2021. Aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.89-46/E-176211/2021 Appeal/9 Mtg.-2021/25th February, 2021 dated 26.03.2021 appeal remand back the Order appealed against. The institution has submitted letter dated 13.04.2020 reply to the appeal remand back case.
- AND WHEREAS, the matter was further considered by the SRC in its 399th meeting held on June 15th - 16th, 2021 and the Committee decided as follows: -

- 7. NOW THEREFORE, this order is issued permitting the institution i.e. Deccan B.Ed. College, Survey No. 34/2 Azadpur Village Tq. & District Gulbarga -585102, Karnataka run by Deccan Education Society, Gulbarga, Karnataka for continuation of recognition for B.Ed. programme for two years duration (2 basic units) of 50 students each subject to fulfilment of the following conditions:
